Balloting will be used to determine the order of priority. The persons interested in purchasing any of the specified residential properties (“**the registrant(s)**”) must follow the procedures below:-

以抽籤方式決定揀選住宅物業的優先次序，有意購買該等指明住宅物業的人士（下稱「登記人」）須遵從下列程序：

1. Registrations of Intent will be distributed at Shop on Ground Floor, No. 6 Shung Shun Street, Yau Tong, Kowloon, Hong Kong (“**Sales Office**”). Persons interested in purchasing any of the specified residential property must personally attend the Sales Office from 11:00 a.m. to 11:30 a.m. on 28 June 2019 (the “Attendance Registration Period”) and submit:
 - (a) the Registration of Intent duly completed and signed by the registrant;
 - (b) one cashier’s order in the sum of HK\$100,000 if the person is interested in purchasing 1 specified residential property (or 2 cashier orders each in the sum of HK\$100,000 if the person is interested in purchasing 2 specified residential properties) and made payable to “Mayer Brown”; and
 - (c) (if the registrant(s) is/are individual(s)) copy(ies) of the H.K.I.D. Card(s) or Passport(s) of the registrant (as the case may be) or (if the registrant is a company) a copy of the valid Business Registration Certificate, Certificate of Incorporation, the company chop, the latest Annual Return of the registrant and the H.K.I.D. Card(s) or passport(s) (as the case may be) of the relevant director(s) of the registrant(s) who attend the registration.

After the selection of the specified residential properties as aforesaid, the remaining specified residential properties, if any, will be sold on a first come first served basis.
