Persons interested in purchasing the specified residential property must personally attend the Sales Office from 11:00 a.m. to 11:30 a.m. on 7 August 2021(the “Attendance Registration Period”) and submit:</p> <ul style="list-style-type: none"> (a) the Registration of Intent duly completed and signed by the registrant; (b) one cashier’s order in the sum of HK\$100,000 and made payable to “Mayer Brown”; and (c) (if the registrant(s) is/are individual(s)) copy(ies) of the H.K.I.D. Card(s) or Passport(s) of the registrant (as the case may be) or (if the registrant is a company) a copy of the valid Business Registration Certificate, Certificate of Incorporation, the company chop, the latest Annual Return of the registrant and the H.K.I.D. Card(s) or passport(s) (as the case may be) of the relevant director(s) of the registrant(s) who attend the registration. <p>to Sales Office for registration (a person completing the aforesaid procedures is referred to as a “Registrant”). 2. If during the Attendance Registration Period, more than one Registrant express interest to purchase the specified residential property, balloting will be used to determine the order of priority in which each of such Registrants may purchase that specified residential property.

3. Upon the expiry of the Attendance Registration Period, each Registrant shall proceed to select and purchase the specified residential property in the order of priority as determined by paragraphs 1 and 2 above within reasonable time and in an orderly manner, otherwise his/her order of priority shall lapse automatically. After the selection of the specified residential property as aforesaid, the remaining specified residential property, if any, will be sold on a first come first served basis.
