Persons interested in purchasing any of the specified residential property must personally attend the Sales Office from 11:00 a.m. to 11:30 a.m. on 3 May 2021(the “Attendance Registration Period”) and submit:</p> <ul style="list-style-type: none"> <li>(a) the Registration of Intent duly completed and signed by the registrant;</li> <li>(b) one cashier’s order in the sum of HK\$100,000 if the person is interested in purchasing 1 specified residential property (or 2 cashier orders each in the sum of HK\$100,000 if the person is interested in purchasing 2 specified residential properties) and made payable to “Mayer Brown”; and</li> <li>(c) (if the registrant(s) is/are individual(s)) copy(ies) of the H.K.I.D. Card(s) or Passport(s) of the registrant (as the case may be) or (if the registrant is a company) a copy of the valid Business Registration Certificate, Certificate of Incorporation, the company chop, the latest Annual Return of the registrant and the H.K.I.D. 3. After the selection of the specified residential properties as aforesaid, the remaining specified residential properties, if any, will be sold on a first come first served basis.
